MEMBERSHIP CONDITIONS FOR THE ASSOCIATION GAMING-AID E.V.

Please keep

§ 1 Membership

Any natural person and any legal entity can become a member of the association. The management board can fundamentally reject a membership application. In all other cases, membership in the association is completed with the submission and receipt of the form by representatives of the management board and requires no further declaration from the association.

§ 2 Self-understanding

Every member of Gaming-Aid e. V. is expected to identify with the goals of the association and support them in the form of his/her membership fee.

Voluntary support (e.g., through voluntary activities, announcements, fundraising calls, etc.) further supports the association and is encouraged.

§ 3 Membership Payments

Fees are always collected at the beginning of a calendar year for a full calendar year and are due by mid-February at the latest. Membership automatically extends at the beginning of each subsequent calendar year. Since the association has been registered under SEPA, there is the possibility of electronic direct debit, which can be filled out separately.

§ 4 Change of Status

The new member is obligated to report any changes to the personal data provided in the membership form promptly or at the latest four weeks after the change occurs. Incorrect information can lead to immediate expulsion from the association.

§ 5 Termination

Termination with a declaration of withdrawal from the association must be submitted in writing to the board at the association's address. A reason is not necessary. The notice period is three months to the end of the fiscal year. After receiving the termination notice, the remaining annual fee for the remaining months will be promptly refunded.

§ 6 Final Provisions
